
Properties can be let if they have an energy rating from A to E.

Energy rating and score

Properties get a rating from A (best) to G (worst) and a score. The better the rating and score, the lower your energy bills are likely to be.

Primary energy use

The primary energy use for this property per year is 232 kilowatt hours per square metre (kWh/m2).

How this affects your energy bills

An average household would need to spend £1,049 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

You could **save £148 per year** if you complete the suggested steps for improving this property's energy rating.
